

What is The Amy Casey Leadership Award?

The Amy Casey Leadership Award was established in recognition of Amy Casey's significant contribution to The G. Raymond Chang School of Continuing Education during her 13 years as Associate Director of the school. The award will provide financial assistance and recognize the academic achievement of an exceptional Chang School continuing education student.

What is the value of The Amy Casey Leadership Award?

There is one annual award valued at \$1,000.

Who is eligible to apply?

To be eligible to apply for The Amy Casey Leadership Award you must meet all of the following criteria:

1. Be a Chang School continuing education student registered in a Business certificate program
2. Have successfully completed a minimum of 50% of a Business certificate program
3. Have maintained a minimum cumulative grade point average (CGPA) of 3.0 (B)
4. Be a Canadian Citizen, Permanent Resident, or Protected Person (with valid PPSD)
5. Be an Ontario resident for at least one year (12 consecutive months)

Who is ineligible to apply?

You are ineligible to apply if you have received the award in the past.

How will students be selected?

Students will be evaluated and ranked according to the following criteria:

1. Evidence of academic achievement (*Unofficial Transcript*)
2. Letter from your employer or colleague that supports the application and demonstrates how your knowledge has made a significant difference within your place of employment

Students are expected to be honest in providing information on the application and in any subsequent discussions. If there is clear evidence that an student has misrepresented their circumstances or achievements, the award will be refused or withdrawn.

Application and Notification

The Amy Casey Leadership Award application is available online on The Chang School website and at The G. Raymond Chang School of Continuing Education, Heaslip House, 297 Victoria Street. Your completed application must be printed and handed in at the information desk in The Chang School lobby by **4:00 p.m. on Friday, August 18, 2017**.

All students will be notified by email. The successful student will have their name posted on The Chang School website and a formal presentation of this award will be made at The Chang School Awards ceremony in Fall 2017.
