

## What is The Marilyn Booth Award?

Marilynn Booth served as Dean of The G. Raymond Chang School of Continuing Education from 1993 through 2005. The Marilyn Booth Award was established in recognition of her immense and lasting contribution to The Chang School, Ryerson University, and the Canadian and international continuing education communities. It acknowledges her commitment to adult learners and lifelong learning. The award recognizes demonstrated academic objectives, academic performance, and financial need. The award provides financial assistance and rewards Chang School continuing education students in two categories, a new student and a returning student.

## What is the value of The Marilyn Booth Award?

Awards are valued at \$1,000 (per student). The number of awards will vary from year to year.

## Who is eligible to apply?

Eligibility for **All** Students:

1. Be a Canadian Citizen, Permanent Resident, or Protected Person (with valid *PPSD*)
2. Be an Ontario resident for at least one year (12 consecutive months)
3. Have demonstrated financial need (see Application, Part 3)

Eligibility for **New** Students:

1. Be a Chang School continuing education student enrolled in your first course and considering registration in a certificate program

Eligibility for **Returning** Students:

1. Be a Chang School continuing education student enrolled in a course and registered in a certificate program
2. Have successfully completed a minimum of three courses through The Chang School
3. Have maintained a minimum cumulative grade point average (CGPA) of 3.0 (B)

## Who is ineligible to apply?

You are ineligible to apply if you have received the award in the past.

## How will students be selected?

Students will be evaluated and ranked according to the following criteria:

- All Students - essay (approximately 250 words) outlining your life and/or career aspirations and how this award would help you to achieve your goals
- Returning Students - evidence of academic achievement (*Unofficial Transcript*)

Students are expected to be honest in providing information on the application and in any subsequent discussions. If there is clear evidence that a student has misrepresented their circumstances or achievements, the award will be refused or withdrawn.

## Application and Notification

The Marilyn Booth Award application is available online on The Chang School website and at The G. Raymond Chang School of Continuing Education, Heaslip House, 297 Victoria Street. Your completed application must be printed and handed in at the information desk in The Chang School lobby by **4:00 p.m. on Friday, August 18, 2017**.

All students will be notified by email. The successful students will have their name posted on The Chang School website and a formal presentation of this award will be made at The Chang School Awards ceremony in Fall 2017.
